I enclose a grievance docketed by the Secretary of the District Ethics Committee. In accordance with Supreme Court rules, I have been appointed to investigate this case, determine the facts and report to the chair of the Ethics Committee in writing.

Please review this grievance and provide me with a written response to the allegations made within **ten days** of your receipt of this letter. Please attach copies of any documents or letters that would help me to understand the matter. A copy of your response will be furnished to any grievant and you will receive a copy of any further reply filed by any grievant. As a result of the filing of this grievance, you are required, pursuant to R.1:20-3(g)(3) and R.P.C. 1.6(d)(2), to reveal otherwise

confidential information to the extent necessary to establish a defense to this allegation of unethical conduct. I request that you make a full, candid and complete disclosure of all facts reasonably within the scope of the transactions set forth in the grievance. In re Gavel, 22 N.J. 248,263 (1956). This will help me to determine what the facts are and to make an appropriate recommendation to the chair.

Your prompt consideration and response are essential. In the absence of a timely and adequate reply, I must still complete my investigation and may have to assume that the facts as stated by the grievant are true. I trust your prompt response will allow me to find out what the facts are rather than having to make a judgment based upon assumptions. Please call me if you have any questions and I will be glad to discuss the matter with you.

Please be further advised that the grievant provided extensive attachments in support of his grievance and the same are available to be viewed in my office and copies can be made of any document at that time.
